2009 Terms of Enrollment

- Campers must be paid in full and their medical form must be completely filled out and signed before attending camp. Medical attention from camp medical staff is included in tuition. This does not include cost of prescriptions, special doctor fees, trips to the doctor, or hospital care.
- Tuition includes uniform (5 camp T-shirt), laundry, trial horseback riding, and one adventure trip (up to \$130). Some trips are more expensive and will be billed if a premium is required for a trip which is selected by camper.
- The camp uniform is a camp T-shirt plus blue, white or khaki shorts (or pants on cold or rainy days). Campers will be required to wear camp uniforms daily except for special days like optional Friday and theme days.
- Camp is a wholesome environment for children. Clothing or swimwear that is too revealing or inappropriate (i.e. spaghetti straps, bikinis, pants or shorts too low etc.), in the sole discretion of the camp director, will not be permitted. Campers need to comply or will be asked to leave, without refund.
- Store items such as bottled water, candy, logo wear, sundry items, and gifts are available most days and, along with riding, special craft supplies and other optional purchases are billed separately.
- Refunds and Cancellations: Unless otherwise specified, there will be no refund(s) for cancellations or deposits after December 31st.
- Cancellation or camp interruption insurance due to certain medical illness may be available upon request—please contact the camp if you are interested.
- Tuition is not prorated for arriving late or leaving early.
- Early bird discount and/or any other discount(s) may not be combined.
- Counselor in Training (CIT) tuition is considered a form of discount.
- Firebird Camp and Camp Roosevelt reserve the right to dismiss, without refund, any camper, whose behavior, in the camp director's sole discretion, is inappropriate, or may be harmful to another camper or the camp community.
- Parent(s) or legal guardian grants camper permission to participate in all supervised camp activities, including camp supervised optional trips and programs chosen by camper. The parent understands that some camp supervised programs and/or optional trips may take place outside of camp.
- Parent(s) or legal guardian authorizes camp to bill them for optional trips chosen by camper and merchandise purchased by camper at the camp store (sundry items, camp logo wear, flashlights, gifts, etc.).
- Parent(s) or legal guardian will be held responsible for the payment of repairs or replacement of the camps' or another individuals' property or equipment damaged by the camper due to neglect or misbehavior (e.g. graffiti on new wood interiors of cabins).
- The parent(s) or legal guardian authorizes the use of camper and family photographs, names, quotes, and video for promotional materials (such as videos, brochures, displays, etc.) by Camps Firebird and Roosevelt.
- Camp is situated in a heavily wooded area. Sometimes, mice and other critters can be attracted to areas with food. While typically harmless, mice may go into cabins if there is food or crumbs. Therefore, for health and sanitary reasons, unless previously arranged by the parent and the Camp Director for specially designated events, care packages/food/candy/etc. are not allowed at camp. All care packages will be subject to inspection and all food/candy/etc. will be confiscated upon arrival. This is a health issue and thank you for cooperating.
- Any individual, group, or entity bringing legal action against Camp Firebird LLC, its officers, owners, employees, agents, associates or vendors, which results in a decision in favor of Camp Firebird LLC, its officers, owners, employees, agents, associates or vendors, will be responsible for all related legal, court, and all expenses incurred by Camp Firebird LLC, its officers, owners, employees, agents, associates or vendors.
